Closure of various Sub-Funds of the ICAV - FINAL Follow-up Announcement

Confirmation of Liquidation Procedure

Further the announcements made by the ICAV on 8 July 2020, 11 August 2020 and 24 August 2020, the ICAV desires to remind investors that all of the shares in all the share classes of the Closing Funds (as set out at Appendix 1), are to be compulsorily redeemed and that the ICAV has nominated 8 September 2020 to be the compulsory redemption date for all share classes of the Closing Funds except for WisdomTree CBOE S&P 500 PutWrite UCITS ETF, in respect of which the ICAV has nominated 11 September 2020 to be the compulsory redemption date.

The ICAV desires to also to remind all shareholders on the register and underlying investors, it is expected that the Redeeming Shares will stop trading on their respective exchanges after the close of trading **today**, **27 August 2020**.

Further to the announcement made by the ICAV on 8 July 2020, which mentioned that the ICAV may need to sell off some of the underlying assets in the Closing Funds in the days leading up to the relevant Compulsory Redemption Date to ensure an efficient liquidation of the underlying assets. The ICAV can now describe when the sale of the underlying assets of the Closing Funds will begin to occur (the "**Liquidation Trade Date**"), this is set out at Appendix 2.
