Description of Activity	<p>Over the course of the inspection, we performed procedures including but not limited to:</p> <ul style="list-style-type: none">• Compared the records of the Custodian to the records provided by the Administrator to verify that the palladium bars are held in the name of the applicable account;• Reconciled the total weight of palladium bullion as recorded by the Administrator to the records of the Custodian as at the Audit Reference Date;• Visually checked each bar for the bar number, brand and purity;• Weighed a random sample of palladium bars, equating to approximately 5 percent of the bar list. Bars were weighed in troy ounces to the nearest thousandth of an ounce. Details of each bar weighed were recorded;• Reconciled the physical movement of bars which occurred during the inspection period of 13 May 2021 to 28 May 2021.
Anomalies	<p>No anomalies were identified in respect of the palladium bars as at 13 May 2021.</p>

The audit was carried out to the best of our knowledge and this report reflects our findings as at the time and place of the audit only.
